Three councillors voted against the application and one member abstained.

The following comments are to be sent to Charnwood Borough Council regarding this application.

P.W.W.

- Concerned about the infrastructure in the village - sewerage (we are waiting for Severn Trent to sort the storm and sewerage problems with flooding in Cossington.), electricity supply and gas supply (this has been in for very many years and has not been updated).
- Safety of pedestrians and car drivers on Platts Lane. When vehicles are coming out of the site. Two, five bedroom houses could have eight cars.

- The houses are approximately 10ft in front of the building line.
- The sewer through the village needs updating before any more properties are built.
- The ditch at the bottom of the plot takes flood water from beyond the railway line and the fields next to Middlefield Road.
- We feel the village needs affordable housing before more large houses are built.
- Platts Lane entrance goes over the culvert which was put in about year 2000 and was not built to take heavy vehicles and traffic from the houses.
- Platts Lane is too narrow for vehicles coming off the site and turning left towards the village.
- Main Street is far too busy at present to take any more traffic.
- If the application goes to committee we would like a representative to speak from Cossington Parish Council.
