Leicestershire County Councillor Update Cllr Houseman informed the Councillors of the proposed changes survey for the Mental Health Support Services in Leicestershire which Leicestershire County Council are running. Charnwood Borough Councillor Update Charnwood Borough Council is participating in a fraud-busting initiative being launched nationally to protect public funds. The National Fraud Initiative (NFI) is carried out every two years, and uses sophisticated ‘data matching’ techniques to analyse computer records held by around 1,300 public sector organisations and 77 private sector organisations to identify suspicious cases for further investigation.</p> <p>Once every two years they are legally obliged to share information with the Cabinet Office as part of the NFI scheme.</p> <p>This is a vitally important programme designed to not only detect fraud but to also prevent it from happening.
